Rules and Regulations

All participants must be 18 or older.

A team of four contestants will race the outhouse down a 100 yard stretch of North High Street.

Three members will push the outhouse down the course and one will be the rider on the seat in the appropriate clothing.

Boxers must be worn over street clothes and pulled down below the knees once you've been seated at the start of the race.

Your race cannot begin until your rider is seated and the boxers are below the knees.

The outhouse must remain in the designated lane.

The outhouse should go around the cone and STOP.

Once the team reaches the midpoint of the course, they will switch riders. The boxers should then be worn by the second rider. The second rider will also be seated with the boxers below the knees before taking off for the finish line.

The team who completes the course from start to finish with the quickest time wins the contest.

Penalties

There will be a five second penalty if the boxers are not below the knees before the team takes off.

There will be a five second penalty if the rider jumps off prior to the midpoint or the finish line of the course.

There will be a five second penalty if the cone is knocked over.

Prizes will be presented to the top three teams with the quickest times.
